

This affiant, Investigator Alfred Sternberg, has been in law enforcement for 19 years. I am currently assigned to the Wake County Sheriff's Office Investigations Division. This unit investigates murders, rapes, frauds, computer crimes, arsons and violent crimes. During the course of my employment as a law enforcement officer, I have been trained in these areas of investigation, crime scene searches and arrest of criminals that are involved in such crimes. **Michelle Marie Fisher Young** was found brutally murdered on November 3, 2006 in her home at **5108 Birchleaf Drive Raleigh, NC in Wake County**. Wake County Sheriff's Office is engaged in an ongoing process of investigative reconstruction of events leading up to the murder, the time period of the murder itself, and the events in the aftermath. **Jason Young** is the victim's husband. **Jason Young** has been uncooperative in the murder of his own wife other than responding to service of a Non-Testimonial Identification Order and the briefest conversation where he referred law enforcement investigators to his attorney. Investigation revealed that **Jason Young** was an avid cell phone text message sender and receiver. **Jason Young** was found to engage in detailed email discussions with case witnesses about the investigation of the murder of his wife. WCSO Investigator McCormack told me on June 29, 2007 of information obtained under court order of **Jason Young** being in recent June 2007 phone and text message contacts with key case witnesses who were among those he had history of also being in email contact. This contact included renewed communications with at least one witness he had last been known to contact on the date the murder victim was found. The affected calls and text messaging were done using a **Cellco Partnership DBA Verizon Wireless** account **864-430-7103**.

Continuation of: Conclusion;

Based upon my training and experience, it is believed the preceding facts establish probable cause to believe the above-described items in possession of **Cellco Partnership DBA Verizon Wireless** will be found and will aid in identifications that will assist in identifying the person or persons responsible for the crime of **Murder NCGS 14-17** for the death of the victim. For these reasons, your affiant respectfully requests this warrant.
